

#### OH is suitable for:

Advocacy projects / campaigns

Social justice, human rights

Governance, social accountability, laws

Innovations

Projects with many actors involved





### Why OH suits for complex projects?



- Capture unexpected outcomes
- Allow for flexibility
- Project stakeholders, beneficiaries and other change agents can be involved directly
- Capture small and big results
- Capture positive and negative outcomes
- No need for a result framework or indicators



## What is OH?

A method to identify, formulate, analyse and interpret outcomes to answer monitoring and evaluation questions

From focusing on what is done to focusing on what is achieved

Working backwards to determine whether and how the intervention contributed to the change

No measurement of progress towards predetermined outcomes or objectives!






# Use of Outcome Harvesting Learning cycle



- OH can be used to assess the validity of a ToC
- important input for reviewing our progress towards our objectives
- Contribute to reporting and provide input for indicators
- Feed into advocacy and communication, use examples of outcomes
- Link with learning and feed into learning agenda/questions
- Support planning by informing and adjusting annual plans, work/ activity plans



#### The Outcome Harvesting 'formula'



#### In wordings:

An **observable and significant change** in a **social actor's** behaviour, relationships, activities, policies or practice that has been achieved, and that has been **influenced by the project intervention**
